  7. Please identify any commitments which might prevent you from attending regularly scheduled meetings, participating in workshops, and reviewing study materials prior to meetings?
  8. What has been your involvement in the schools and/or community of North Kitsap or elsewhere?
  9. What do you think are the district's greatest strengths and most pressing issue? What do you see as the Board's role in supporting district work in these areas?
  10. Please define "equity" as it relates to student learning and expenditures per student. Within the constraints of the law, do you believe that the district should provide equal expenditures for all students?
  11. Consider some of the support areas that are outside of the classroom like busing, maintenance, and food service. How do you see these functions for schools being different than similar functions of non-school related venues?
  12. What have you been reading lately? What have you learned from that and how does it relate to your potential service as NKSD board member?
  13. Are you first a representative of the community to the district or first a representative of the district to the community?
  14. Please take this opportunity to ask any questions that you have for us.
