- Dr. Evans attended the OESD 114 Safety & Security Cooperative meeting. We are in the process of updating security measures at several of our schools within the district.
- Dr. Evans and Poulsbo Mayor, Becky Erickson visited North Kitsap High School and Vinland Elementary. Today Dr. Evans, and Kitsap County Commissioner Rob Gelder visited Kington High School, Kingston Middle School, and Gordon Elementary. Dr. Evans will continue to invite local leaders to visit our schools.
